RESCHEDULING OF CANDIDATES AFFECTED FOR THE LEVEL-1(GROUP-D)  
EXAMINATION BY RAIL ROKO IN SOUTH EASTERN RAILWAY ON 24.09.2018

Examination of Level-1(Group-D) was affected for a number of candidates on account of Rail Roko in South Eastern Railway on 24.09.2018. A Notice was uploaded in the website requesting the candidates to submit their details (name, registration number, date of birth), copy of e-call letter, copy of railway ticket(if available) in RRB/Kolkata's email address – kolrrb@gmail.com for verification of records. Accordingly, all applications and emails received in the above email id till 14.10.2018 are being considered for rescheduling. Based on the email and documents submitted by the candidates and subsequent verification, following candidates are being considered for rescheduling of examination.

1. All candidates residing in West Bengal and had exam at **Bhubaneswar** and **Jamshedpur** on **25.09.2018** for **all the three shifts** and who could not attend exam and who have submitted copy of either copy of e-call letter or railway ticket or address proof (for RRB/Kolkata candidates) and copy of e-call letter or railway ticket **as well as address proof** (for other than RRB/Kolkata candidates) have been considered for rescheduling after due verification of their residential address(for RRB/Kolkata candidates) as per the candidates data base.
2. All candidates residing in West Bengal who had exam at **Bhubaneswar** on **24.09.2018 for 3<sup>rd</sup> shift only** and who could not attend exam and who have submitted copy of either copy of e-call letter or railway ticket or address proof (for RRB/Kolkata candidates) and copy of e-call letter or railway ticket **as well as address proof** (for other than RRB/Kolkata candidates) have been considered for rescheduling after due verification of their residential address(for RRB/Kolkata candidates) as per the candidates data base.
3. All candidates residing in West Bengal and who had exam at **Balasore** and **Jamshedpur** on **24.09.2018 for all three shifts** and who could not attend exam and who have submitted copy of either e-call letter or railway ticket or address proof (for RRB/Kolkata candidates) and copy of e-call letter or railway ticket as well as address proof (for other than RRB/Kolkata candidates) have been considered for rescheduling after due verification of their residential address (for RRB/Kolkata candidates) as per the candidates data base.

All candidates residing in the district of Midnapore (East & West), Bankura, Purulia & Howrah of West Bengal and who had exam at other districts of West Bengal (including Bankura) on **24.09.2018 for all three shifts** and who could not attend the exam and have submitted copy of either e-call letter or railway ticket or address proof (for RRB/Kolkata candidates) and copy of e-call letter or railway ticket as well as address proof (for other than RRB/Kolkata candidates) have been considered for rescheduling after due verification of their residential address (for RRB/Kolkata candidates) as per the candidates data base.
5. All candidates who had exam at Bankura on **24.09.2018 for all three shifts** and who could not attend the exam and having residential address in district other than Bankura and who have submitted copy of either e-call letter or railway ticket or address proof (for RRB/Kolkata candidates) and copy of e-call letter or railway ticket **as well as address proof** (for other than RRB/Kolkata candidates) have been considered for rescheduling after due verification of their residential address (for RRB/Kolkata candidate) as per the candidates data base.
6. Candidates who had examination on 24.09.2018 and 25.09.2018 and who could not attend the exam and have both exam centres and residences in the districts other than Midnapore(East&West), Bankura, Purulia and Howrah **have not been considered** for rescheduling.
7. Candidates who had not submitted copy of e-call letter but submitted only copy of free travel authority **have not been considered** for re-scheduling.

No more further emails/applications will be entertained for rescheduling of the candidates on account of rail roko in South Eastern Railway.
